Injury from surface (wet floor / glass / debris)	1/10	MLR	Area will be thoroughly checked before children are allowed on.  Any obstruction will be fully cleared away, if this is not possible that area will be sectioned off.	Not occurred
Toilets – children integrating with members of public and unsafe situations	1/10	LR	Children will be advised of the toilet areas but will have to inform AVSSP staff/leaders on where they are going. Staff will monitor when and how many children are going to the toilet at a given time. Public use of the same toilets is restricted.
